- Molded nose bridge comfortably fits a variety of face shapes and sizes. Reduces adjustment needed to insure proper fit and is compatible with spectacles.
- Electrostatic non-woven polypropylene polyester fibers that ensure filtration performance.
- Dual welded head straps keep the respirator comfortably on the user's face.
- Latex free woven suspension straps reduce the possibility of breakage and do not pull or tangle hair.
- Lightweight construction allows for longer wear time and less fatigue.
- Soft inner lining for extended comfort.
